Robert Silvers is a partner in the Washington, D.C. office. He is vice-chair of the firm's Privacy and Cybersecurity practice, co-chair of the Artificial Intelligence (AI) practice, and a member of the Investigations and White Collar Defense practice. Mr. Silvers formerly served in senior roles at the U.S. Department of Homeland Security (DHS) during the Obama administration, most recently as Assistant Secretary for Cyber Policy. Mr. Silvers represents companies in global internal investigations and enforcement proceedings, cybersecurity and data privacy, government security review of foreign investments, AI governance and risk mitigation, and civil litigation at the intersection of law and technology.

As the most senior official for cybersecurity policy at DHS, Mr. Silvers was responsible for the federal government's engagement on cyber defense with the private sector, its response during significant cyber incidents, and its pursuit of law enforcement cyber investigations. Mr. Silvers also drove administration policy on technology risk issues ranging from government access to encrypted data to security challenges involving intelligent and autonomous systems. In his prior role as DHS Deputy Chief of Staff, Mr. Silvers oversaw all law enforcement activities, litigation, regulatory processes, Committee on Foreign Investment in the United States (CFIUS) proceedings, policy, and operations across the third largest cabinet department, with over 230,000 personnel, a \$40 billion budget, and 22 subordinate agencies.

Mr. Silvers is a nationally recognized expert on technology risk, data protection, government enforcement, and investigations and litigation arising from those issues. He is regularly quoted in *The New York Times*, *The Wall Street Journal*, *Financial Times*, CNBC, Bloomberg and other media outlets.

Mr. Silvers is a senior adjunct fellow at the NYU School of Law's Center on Law and Security and an adjunct professor in cybersecurity at NYU School of Law and NYU Tandon School of Engineering. He serves on the Security Advisory Board of the Secure Community Network, the Jewish Federation's operational arm charged with providing security assistance to Jewish community

Committee on Foreign Investment in the United States (CFIUS)

During his government service and in private practice, Mr. Silvers has played a substantial role in many of the most high-profile and challenging CFIUS reviews over the last decade.

Mr. Silvers negotiated with the U.S. government certain assurances that persuaded CFIUS to declare that all national security concerns had been resolved. As Assistant Secretary for Cyber Policy at DHS, Mr. Silvers led all cybersecurity policy decisions at the agency charged with ensuring the cybersecurity of critical infrastructure and the private sector in the United States. He routinely navigated crisis response in coordination with victim companies across a range of critical industries, including financial services, energy, healthcare, aviation, and technology. He also regularly participated in White House Situation Room meetings to determine the U.S. government's response to some of the most high-profile security events in recent years.

As DHS Deputy Chief of Staff, Mr. Silvers managed the day-to-day policy and operations of the Secret Service, Customs and Border Protection, Transportation Security Administration, Citizenship and Immigration Services, Federal Emergency Management Agency, Coast Guard, and Immigration and Customs Enforcement. In this capacity, Mr. Silvers had direct oversight over the Department's law enforcement and counterterrorism programs; its security review of foreign investment under the CFIUS process; and an array of immigration, border, economic crime, travel facilitation, aviation security, and cybersecurity priorities.

While at DHS, Mr. Silvers led crisis management for some of the most challenging security events the U.S. government has faced, including foreign and domestic terrorist attacks, cyber attacks against critical infrastructure companies, the surge of unaccompanied children crossing the U.S. southern border in 2014, and the Ebola crisis.
