**Timothy L. Dickinson** is a partner in the Litigation practice of Paul Hastings and is based in the firm's Washington, D.C. office. Mr. Dickinson works with a wide range of industries onanti-corruption matters, including establishment and implementation of compliance programs, due diligence for third parties and acquisitions, and special investigations and defense before regulators in the U.S. as well as abroad, including the U.K.'s Serious Fraud Office. In 2005, he was appointed Independent Expert by Monsanto as part of a Deferred Prosecution Agreement with the Department of Justice and also served as Independent Monitor for another company from 2010-2013. Mr. Dickinson was also selected by the World Bank to assist with the development of their Voluntary Disclosure Program, and participated with Bank staff in evaluating and recommending improvements to a VDP participant's compliance program. He alsohas significant experience advocating for clients with multilateral development banks, including The World Bank and the African Development Bank. *Chambers USA* has recognized Mr. Dickinson as one of a very few top-tier FCPA experts, every year from 2009 through 2018; he was also named by Ethisphere at the top of their FCPA 2009 list of *Attorneys Who Matter*.

Mr. Dickinson was an adjunct professor of law at Georgetown University Law Center from 1983 to 1993.
